The Project Navigator is a tool developed by the International Renewable Energy Agency (IRENA), designed to facilitate the development of bankable renewable energy projects by making the overall project development process more transparent, systematic and explicit.

The context and conditions of Renewable Energy Technology (RET) project development vary significantly across regions and countries. Therefore, the workshop aims to formulate a regional adaptation of the Project Navigator that will meet the specific needs of Small Island Developing States (SIDS) and West Africa. In addition, the workshop will focus on improving the quality of project proposals for banks and tenders, increasing the transparency of RET finance and facilitating communication between RET project stakeholders in Cabo Verde.
