### Session 1: Interactive discussion on financing renewable energy in the region

### Discussion topics:

- Participants' experience in development and financing of renewable energy projects in the region lessons learnt and best practices that can be replicated.
- Identification of priority action areas to increase investors' ability to fund renewables in the region:
  - Analysis, technical skills and assistance needs:
    - Resource potential, data collection/quality
  - Capital availability/cost, financial engineering capabilities:
    - Local capital availability (at sufficiently long tenors)
    - How can the high cost of capital barrier be alleviated?
    - Financing structures for renewable energy projects
    - Availability and affordability of risk mitigation instruments
  - Bankability of renewable projects:
    - Project scale (large-scale vs. small-scale financing requirements/needs)
    - Documentation terms
- How can greater cooperation between policy makers, public finance and private actors be achieved? What formats could this cooperation take? Examples of successful methods/initiatives (national, regional level).
- Support that IRENA can provide to advance action at national and regional level, ensuring synergies with existing programmes. Feedback and suggestions for facilitating platforms, initiatives, trainings or other actions.
