**Nigel Topping, UK High-Level Champion for COP26**

Nigel Topping is the UN’s High-Level Climate Action Champion, appointed by the UK Prime Minister in January 2020. Nigel works alongside the Chilean High-Level Climate Action Champion, Gonzalo Muñoz. The role of the high-level champions is to strengthen collaboration and drive action from businesses, investors, organisations, cities, and regions on climate change, and coordinate this work with governments and parties to the United Nations Framework Convention on Climate Change (UNFCCC).

Nigel was most recently CEO of We Mean Business, a coalition of businesses working to accelerate the transition to a zero carbon economy. Prior to that he was Executive Director of the Carbon Disclosure Project, following an 18 year career in the private sector, having worked across the world in emerging markets and manufacturing.

**Rana Adib, Executive Director, REN21**

She was also responsible for coordinating the biogas-to-energy research programme of Veolia Environment. The 3-year Transform Freetown plan details 19 concrete targets across 11 sectors, with community owned climate action that facilitates job creation and improved living standards of our residents at the heart. A finance professional with over 25 years of private sector experience.



**José Donoso, Chairman, Global Solar Council**

José Donoso has been working in the Renewable Sector for more than 30 years.

He started at the Institute for Energy Diversification and Saving (IDAE). After that, he joined Gamesa, a Spanish wind energy company, as Development Director. During this period he combines this work with that of President of the Spanish Wind Energy Association (AEE). After that, and until now, he has been the General Director of UNEF (Spanish Photovoltaic Energy Association). He is also president of the Spanish Photovoltaic Technology Platform (Fotoplat) and member of the Advisory Board of the Electricity Market Organization (OMEL).

At international level, he is member of the Task 1 of the International Energy Agency and Elected President of the Global Solar Council.

Besides, he is professor in the post grade course in Wind Energy of the University Polytechnic of Madrid and in the Master Course of the Industrial Organization School.

Linear and incremental changes in the power sector will not achieve the speed and scale of systems transformation needed to limit temperature rise to 1.5° C. This session will describe what a resilient and adaptable power system would look like, and what integrated financial, regulatory, and social interventions would take to get us there. Everyone talks about the need for system change, this talk would spell out what that looks like in practice.



**Francesco La Camera, Director-General, International Renewable Energy Agency (IRENA)**

Francesco La Camera is the Director-General of the International Renewable Energy Agency (IRENA). He was appointed at the Ninth Assembly of IRENA, the ultimate decision-making body of the Agency. Mr. La Camera took office on 4 April 2019 and brings more than thirty years of experience in the fields of climate, sustainability, and international cooperation. In his role, Mr. La Camera is responsible for leading the delivery of IRENA's work programme and strategy in cooperation with the Agency's member states.

Previously, Mr. La Camera served as Director-General of Sustainable Development, Environmental Damage, EU and International Affairs at the Italian Ministry of Environment, Land and Sea since 2014. Mr. La Camera held number of roles at the Italian Ministry of Environment, Land and Sea. As the national coordinator for climate, environment, resource efficiency and circular economy, he led the Italian delegation to UNFCCC's COP 21 to 24 and the EU Presidency at COP 20.

Author of many publications, Mr. La Camera was a Lecturer of Sustainable Development at the University of Cosenza and of Environment & Land Economics at the University of Roma 3. He began his career as an economic analyst at the Italian Ministry of Budget and Planning. Mr. La Camera is a graduate of the University of Messina in Political Sciences (Economic Policy major).

**Jules Kortenhorst, CEO, Rocky Mountain Institute**

Jules Kortenhorst is the CEO of RMI. He is a recognized leader on global energy issues and climate change. Prior to RMI, Jules was founding CEO of the European Climate Foundation, the largest philanthropic organization dedicated to policy development and advocacy on climate change in Europe. Before this, he served as a member of the Dutch parliament for the Christian Democratic Party, was CEO for International Operations of ClientLogic Corporation, and also worked for Royal Dutch/Shell and McKinsey.



**H.E. Jeppe Kofod, Minister for Foreign Affairs, Denmark**

Jeppe Kofod was appointed Minister for Foreign Affairs of Denmark on 27 June 2019. Before that he was a Member of the European Parliament (2014-2019), where he served as Vice President of the Socialists & Democrats group and Vice Chairman of the EU-US Delegation. He started his political career as Member of the Danish Parliament for the Social Democratic Party (1998-2014), serving as Chairman (2011-2013) and Vice-Chairman (2001-2008), respectively, of the Foreign Policy Committee of the Danish Parliament. Jeppe Kofod holds a Master of Public Administration from Harvard University (2006-2007) and he graduated from Roskilde University in 2004 (BA.scient.soc.).



**Kadri Simson, Commissioner for Energy, European Commission**

Kadri Simson is an Estonian politician from the Centre Party. She is serving as a European Commissioner for Energy in the Von der Leyen Commission since 1 December 2019.

She was previously the Minister of Economic Affairs and Infrastructure in Jüri Ratas' first cabinet from 2016 to 2019. During the Estonian Presidency in the Council of the EU, Simson chaired both energy ministers and transport ministers meetings in TTE Council and ministers of economy format in EU Competitiveness Council.

From 2007–2016 Kadri Simson was a member of the 11th, 12th, and 13th Riigikogu and in 2019 she was also elected to the 14th Riigikogu. She holds a Master's degree in Political Science from University College London.



**Julie Shuttleworth CEO, Fortescue Future Industries**

Appointed CEO Fortescue Future Industries in August 2020, Julie holds a double major in Extractive Metallurgy and Chemistry and has 27 years' experience in the mining and resources industry globally. Ms Shuttleworth is a Fellow and Chartered Professional of the Australian Institute of Mining and Metallurgy (AusIMM) and was awarded a Member of the Order of Australia in 2021 for significant service to the minerals and mining sector.



**H.E. Abdessalam Mohamed Saleh, Minister of Oil, Mining and Energy, Mauritania**

**Melanie Nakagawa, White House Special Assistant to the President and NSC Senior Director for Climate and Energy**

Melanie Nakagawa serves as the Special Assistant to the President and Senior Director for Climate and Energy at the National Security Council. Her work includes the U.S. return to the Paris Agreement and advancing the Biden-Harris Administration’s policy of integrating climate change into U.S. foreign policy and national security. Most recently, she was the Director of Climate Strategy at Princeville Capital, leading their climate-focused strategy to invest in global growth-stage technology-enabled companies delivering transformative solutions to climate change, and launching their inaugural climate tech fund.

Prior to her investment role, she served in the Obama-Biden administration as the Deputy Assistant Secretary for Energy Transformation at the U.S. State Department and was a strategic advisor on climate change to the U.S. Secretary of State John Kerry. Earlier in her career, she was the Senior Energy and Environment Counsel for the Senate Foreign Relations Committee and an attorney with the Natural Resources Defense Council.

Nakagawa earned a J.D. from American University Washington College of Law, an M.A. in International Affairs from American University’s School of International Service, and an A.B. from Brown University.

## Structural Change: Reshaping the fossil-fuel powered economies

Avoiding dangerous levels of climate change and delivering on the Paris Agreement require a dramatic shift in the way that we provide and use energy. Enabling the transition away from an unsustainable supply of oil and gas is a critical part of that challenge. This segment will focus on the need for a phase out of fossil fuels, while ensuring a just transition where no one is left behind.

#### **Tasneem Essop, Executive Director, CAN international**

Tasneem Essop is currently the Executive Director of Climate Action Network International (CAN-I).

She has just completed serving her second term as Commissioner in the National Planning Commission in South Africa, appointed by the President, and leads the work on Climate Change and the Just Transition.

She previously headed the climate team in WWF International and served as the Head of Delegation for the organisation at the UNFCCC.

She became a Member of the Provincial Parliament in the Western Cape in 1994 and held the positions of Provincial Minister of Transport, Public Works and Property Management from 2001 to 2004 and Provincial Minister for the Environment, Planning and Economic Development from 2004 to 2008 when she resigned from politics.

Tasneem was an anti-apartheid activist from an early age in different capacities until the democratic elections in 1994. During this time she was a student and youth activist, a teacher and a trade unionist.



#### **Andrea Meza Murillo, Minister of Environment and Energy, Costa Rica**

She is an expert in sustainable development with more than 20 years of experience in formulating public policies and executing projects. She has worked in more than 15 Latin American countries in multidisciplinary projects financed by various multilateral organizations (IDB, World Bank, CAF, European Union, UNDP), bilateral (AECID, GIZ) and National governments.



**François Legault, Premier of Québec, Canada**

François Legault was sworn-in as Québec's 32nd Premier on October 18, 2018.

Mr. Legault studied business administration at HEC Montréal. He is a fellow of the Québec Order of chartered professional accountants.

In 1986, he cofounded Air Transat, Canada's leading leisure airline, and served as its CEO until 1997.

Mr. Legault went into politics in 1998 and held several offices in the Québec government. In 2011, he founded and led a new party, Coalition Avenir Québec.

In 2019 Tzeporah received the Climate Breakthrough Project Award and in 2021 she gave a widely-viewed TED Talk presenting the case for a global treaty to phase out fossil fuels.



**Ben Backwell, General Secretary, Global Wind Energy Council**

Ben Backwell is the CEO of the Global Wind Energy Council (GWEC), which represents the major companies and associations in the sector. Mr Backwell is a former journalist, analyst and consultant who wrote a landmark book on the development of the wind energy sector. A political scientist by training, and veteran of past COP meetings and campaigns, Backwell represents the wind industry on a number of advisory boards and panels, and is a frequent speaker at international events and congresses.



**Irene Karani, Africa Director, Children Investment Fund Foundation**

Irene Karani is currently the Africa Director for Climate, at the Children’s Investment Fund Foundation (CIFF). She is based in Nairobi Kenya and her work involves developing the Africa Climate Strategy with a focus on East, West and Southern Africa in energy, climate finance, air quality, cities, agriculture, food and land use systems, nature based solutions and climate resilience, working with partners and grantees to deliver sustainable impact on the continent.



**H.E. Anne Beathe Kristiansen Tvinnereim, Minister of International Development, Norway**

Anne Beathe Tvinnereim (47) was appointed Minister of International Development on 14 October 2021. Anne Beathe Tvinnereim is the deputy leader of the Centre Party. She previously served as the County Councillor for Planning, Climate and Environment in the Viken County Council, State Secretary at the Ministry of Local Government and Regional Development, and Political Adviser at the Ministry of Transport and Communications. She also has worked in the Ministry of Foreign Affairs, Norad and the think tank Agenda. Ms Tvinnereim comes from Halden, Norway, and has a degree in political science.
