TERMS OF REFERENCE

Secretariat of the International Renewable Energy Agency (IRENA) Administration and Management Services (AMS)

Provision of transportation services for IRENA Staff

I.Background

The International Renewable Energy Agency (IRENA) is an inter-governmental organisation mandated by member states to promote the widespread and increased adoption and sustainable use of all forms of renewable energy. IRENA supports countries' capacity to design long-term enabling policy frameworks through providing analyses of policies and measures, including trends in their adoption, and best practices and lessons learnt in their design and adaptation.

II.Objectives

IRENA would like to seek professional services pertaining to the transportation of its staff to and from the Headquarters located in Masdar City, Abu Dhabi. Services shall take place in the morning and evening of each working day and include two (2) bus vehicles in a well maintained condition ready and able to transport staff. In addition, the contractor shall provide two (2) drivers with valid driver's licenses and a driving record free from any violations. In order to facilitate IRENA's staff, the contractor shall accommodate working hours of the Agency as per the schedule in section V below. The contract shall run for a period of one (1) year from the date of signing with possible annual extensions, subject to IRENA's approval.

III.Scope of work

The contractor shall adhere to the mandatory requirements identified in section IV below. To be considered technically capable and qualified, the contractor shall meet all mandatory specifications outlined in the table. IRENA requires two (2) buses running in parallel each working morning for staff transportation, and two (2) buses running an hour apart after working hours (see schedule in section V). The two buses used for transporting staff in the evening shall alternate the assigned routes on weekly basis.
