A. Opening of the 11th Assembly – World Energy Transition Day

Monday, 18 January 2021

To give global leaders and the Membership at large an opportunity to address measures to confront the pandemic, strengthen resilience and transform our world, the opening day of the Assembly is designated the 'World Energy Transition Day'. The opening will feature high-level statements including by the President of the Assembly, the Secretary-General of the United Nations, the Host Country and the Director-General, among others.

A High-level Panel on Energy Transition for Sustainable Post-Covid Recovery will be organised, featuring high-level participants including Heads of State, Ministers, heads of international and regional organisations and private actors, who will share their views on the role of the energy transition driven by renewables as a response to the pandemic and draw out strategies to simultaneously advance multiple economic, social and climate priorities.

B. Annual Report of the Director-General on the Implementation of the Work Programme and Budget for 2020-2021, and Member Interventions

D. Establishment of the Global High-level Forum on Energy Transition

Thursday, 21 January 2021

At the twentieth meeting of the Council, the Chair highlighted that the response to the COVID-19 pandemic has underscored the urgency to intensify efforts and strengthen international cooperation in support of a rapid global energy transition.

With a view to mobilising political momentum required to catalyse these efforts, the Chair proposed that, given IRENA's near-universal membership and convening power, the Council considers the proposal to establish an open-ended Global High-level Forum on Energy Transition in the context of the IRENA Assembly. The Council endorsed the proposal to establish an open-ended, inclusive, Global High-level Forum on Energy Transition at the eleventh session of the Assembly.

To this end, the Chair of the Council, in collaboration with Uganda, President of the 10th Assembly and Spain, President-designate of the 11th session of the Assembly, will present the proposal to establish the above-mentioned Forum as well as its proposed terms of reference for consideration at the 11th session of the Assembly.

II. Ministerial Plenary Meetings

A. National Energy Planning and Implementation for Fostering Energy Transition Tuesday, 19 January 2021

This Ministerial plenary meeting will provide an opportunity to showcase the emerging experience in reinforcing energy planning and implementation at the national level and aligning that to global climate action and Paris Agreement goals through NDCs. This Ministerial will also allow participating Ministers and Heads of Delegation to discuss national priorities in terms of energy transition and climate action in their respective countries, while sharing national experiences and identifying best practices to inform the way forward.

Tuesday, 19 January 2021

This Ministerial plenary meeting will address both policy and finance aspects of channelling investments to the renewable energy sector and achieving a steady pipeline of investor-ready and scalable projects. In addition to Ministers and Heads of Delegation, the meeting will bring together policy makers, leading experts from public and private finance institutions and industry to discuss how to make use of the opportunities that the rapidly evolving renewable energy sector offers.

C. Renewables and Pathway to Carbon Neutrality - Innovation, Green Hydrogen and Socioeconomic Policies

Wednesday, 20 January 2021

This Ministerial plenary meeting will aim to both inspire and inform decision makers by showcasing examples of leadership on strategies for net-zero, sharing plans and experience to date, exploring what actions are most urgent and by strengthening the international engagement crucial to making progress. It will bring together a range of perspectives on the net-zero goal including countries who are pushing ahead and those who are still considering their strategies.

Ministers, Heads of Delegation and other speakers will be invited to share their perspectives and plans on the net-zero goal, with a particular focus on the potential of renewable electricity and fuels (green hydrogen, green synthetic fuels and feedstocks, and sustainable biofuels) in end-use sectors of buildings, industry and transport.

Legislators Forum: Parliamentary actions to scale up renewable investments: Renewable energy as an enabler of services

The 2021 edition of the Legislators Forum brings together parliamentarians to explore short- and long-term actions that can mobilise investments in the renewable energy sector, both at local and national level, and enable services that can create significant economic and employment opportunities, improve healthcare services, address climate change issues as well as food challenges and opportunities in the agriculture sector. Beyond addressing the critical role that renewable energy can have also in the sustainable recovery of countries affected by the COVID-19 pandemic, through the Legislators Forum legislators will also share experience on the various challenges and opportunities that exist in their drive to make the renewable energy agenda a reality while highlighting actionable steps that should be taken to make it a much easier process for their respective countries.

UN High-level Dialogue on Energy 2021: Accelerating progress towards universal energy access and net-zero emissions

Wednesday, 13 January 2021

The Secretary-General of the United Nations will convene a High-level Dialogue on Energy during the UN General Assembly in New York in September 2021. The Dialogue presents a historic opportunity for all stakeholders to come together and accelerate progress towards decarbonised energy systems with universal energy access.

The goal of the High-level Dialogue on Energy is to raise ambition and accelerate action towards the achievement of the SDG7 and the Paris Agreement on climate change, around five Themes: energy access; energy transitions; energy action to advance other SDGs; capacity building and data; and finance and investment. In order to draw on a broad range of expertise and perspectives during the preparations for the Dialogue, a multi-stakeholder Technical Working Group will be established under each Theme to advance in-depth discussions.

This side-event will present the overview of the High-level Dialogue on Energy 2021, and highlight the work ahead, with a focus on the planned activities of the Technical Working Groups. Planned speakers will include UN leadership for the High-level Dialogue, the Director-General of IRENA and other high-level representatives.

Public-Private Dialogue: COVID-19 as a game-changer: Actions needed to accelerate the pace of the energy transition

Thursday, 14 January 2021

This edition of the Public-Private Dialogue will gather policy makers, industry associations, private sector stakeholders and civil society to discuss actions needed to accelerate the pace of the energy transition in a post-COVID recovery. The first session of Dialogue will provide governments with first-hand industry insights on COVID-19 impacts on the renewables sector to date. The second session will discuss how public and private actors are revisiting their recovery and investment plans due to the pandemic and which actions are needed to accelerate the pace of energy transitions.

IRENA Youth Forum: The New Generation of Decision Makers Thursday, 14 January 2021

Building on the first edition of the IRENA Youth Forum in January 2020, the 2021 IRENA Youth Forum will aim at engaging youth for an interactive virtual edition in which various challenges, opportunities, and concerns will be discussed in relation to the theme "Promoting a Just and Inclusive Energy Transition".

The IRENA Youth Forum will provide an opportunity for participants to engage with each other in discussing renewable energy in the context of equity and equality, including the role of renewables in addressing humanitarian challenges, how to create opportunities for youth in the energy transition and promote their voices.
