Fourteenth session of the Assembly Abu Dhabi, 17 to 18 April 2024

Report of the Credentials Committee

Addendum

- 1. The Assembly approved the Report of the Credentials Committee (A/14/5) on 15 January 2024 and the recommendations contained therein on Part I of the session. The Assembly also agreed that the Credentials Committee will continue its work in preparation for Part II of the fourteenth session of the Assembly and will update its report to reflect the status of credentials submitted for the fourteenth session of the Assembly, after the resumption of Part II of the session.
- 2. In this regard, the Credentials Committee met on 17 April 2024 to examine the credentials submitted to the Secretariat in accordance with Rule 25 of the Rules of Procedure of the Assembly in respect of the representatives registered to participate in Part II of the fourteenth session of the Assembly.
- 3. Based on information provided by the Secretariat, the Credentials Committee determined that the credentials submitted by the following 28 Members included in the list referred to in paragraph 5 of the report approved by the Assembly on 15 January 2024 (A/14/5), are valid for Part II of the fourteenth session of the Assembly:
